## **Course Description**

This course introduces students to advanced accounting principles that will prepare them for post-secondary studies in business. Students will learn about financial statements for various forms of business ownership and how those statements are interpreted in making business decisions. This course expands students' knowledge of sources of financing, further develops accounting methods for assets, and introduces accounting for partnerships and corporations.

#### **Procedures**

#### **Late and Missing Assignments:**

It is important for students to develop good personal management skills (including time management and planning). These skills will be reflected in the **Learning Skills** area of the report card including: initiative, responsibility, organization, self-regulation, independent work, and collaboration. All of the Essential Course Components listed above must be submitted and/or demonstrated in order to earn this credit.

#### Attendance:

Attendance in classes is an important part of learning, and absences should be avoided. When a student is absent, a parent/guardian is expected to call the school's attendance line on the date of absence, or provide a note explaining the absence for the student to submit the following day. Students are responsible for what they missed during their absence.

#### **Cheating and Plagiarism:**

- The student will redo all or part of the assignment or assessment; or
- The student will complete an alternate assignment or assessment; or
- The student's work will be treated as a missed assignment.
- Additionally, the student may face disciplinary action (e.g., suspension, detention) and loss of access to academic awards and scholarship opportunities.
- Parents/guardians will be informed about the infraction and the consequences.
